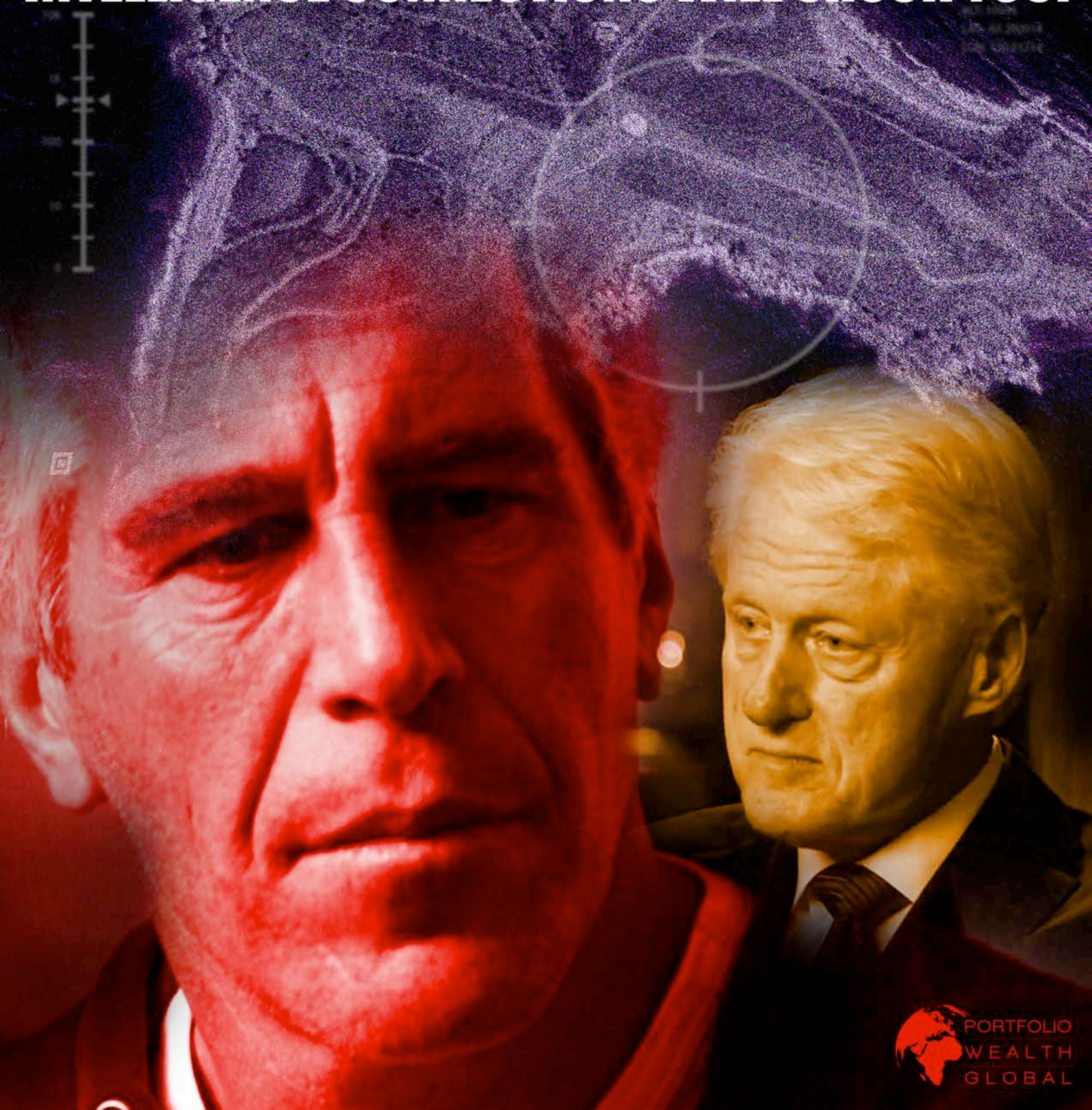

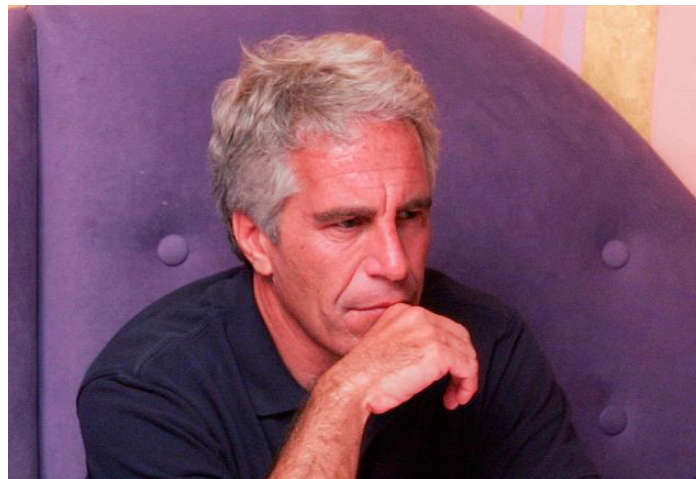

One of Epstein's accusers, Courtney Wild, was heard saying that Epstein's a scary person to be walking the streets – and she's right, but it goes deeper than a child solicitation charge. Reports have made the rounds that Epstein's wealth came not from success as a hedge fund manager, but from something much darker.

Jeffrey Epstein was allegedly pimping out underage girls for congressmen, billionaires, A-list celebrities, and even royalty – and then blackmailing them for hush money. Evidently, Epstein allegedly ran a secret trafficking empire devoted to moving underage girls between New York and Florida for the illicit gratification of these powerful men.

With all of the publicity that this has generated, Alex Acosta has been forced to step down as President Trump's Secretary of Labor, so the public and media got the sacrificial lamb they wanted. Yet with congressmen harboring dark secrets, the looming threat of blackmail and exposure pose a threat to national security, as well as the functionality of the entire U.S. government.

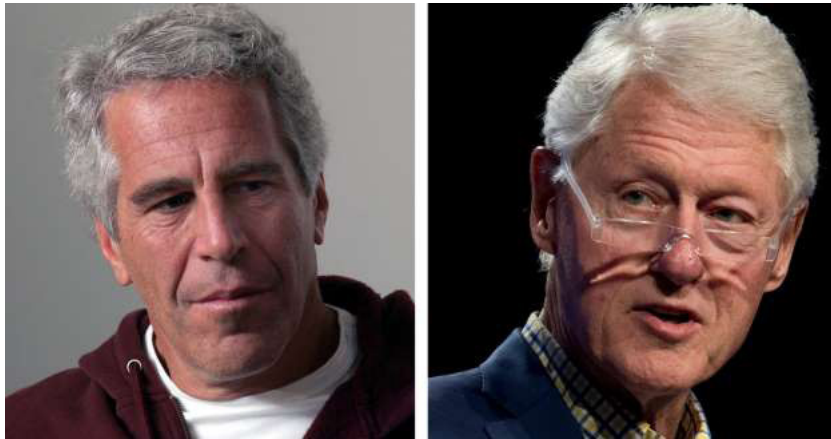

Note that Acosta didn't specify whether Epstein belonged to U.S. or foreign intelligence, thus leaving open the possibility of deep-level spying that would make congressional blackmail seem like a misdemeanor in comparison.

This all begs the question of who Epstein's co-conspirators were – and raises the prospect of an espionage connection. It's certainly no coincidence that Epstein's close friend and business partner for decades was Ghislaine Maxwell, who allegedly served as his key procurer of young girls and was the daughter of Robert Maxwell, a multimillionaire with alleged ties to the British Secret Intelligence Service (MI6), KGB, and Israeli intelligence agency Mossad.

When we connect the dots, it now makes perfect sense that Acosta would have offered Epstein a plumb plea deal with a lesser charge and minimal jail time: such a deal would put a hard stop to a separate federal investigation, effectively immunizing him and his co-conspirators from a much deeper probe.

This also puts Epstein's high-profile friendships into perspective – including his association with Bill Clinton, who used to take international trips on Epstein's plane. It has also been alleged that Clinton was present on Little St. James Island, Epstein's private island in the U.S. Virgin Islands.

More credible is the possibility that Epstein was a blackmailer extraordinaire with FBI and/or CIA connections who wanted a piece of the action.

Most disconcerting of all is the likelihood that Jeffrey Epstein is working with not just one, but multiple competing intelligence agencies. This immediately raises the stakes beyond money and sleaze: world governments and our safety are compromised, and the implications could alter the already threadbare fabric of global stability.
